

## 2012 GOLF ADULT ANNUAL PASS PROGRAM

### Annual Passes Include:

#### **UNLIMITED GOLF**

Annual pass holders receive unlimited rounds of play on all 27 holes of our golf courses. Robert Trent Jones, Sr., designed the 18-hole Springs Course and the North Nine was designed by Andy North and Roger Packard. **All Players must** check-in with golf shop prior to beginning round or any additional rounds or golf holes.

#### **PRACTICE FACILITY**

Annual pass holders have unlimited use of all practice facilities. The practice range offers spacious grass tees and targeted landing areas. The 4 Hole Short Course offers an opportunity to practice those missed greens that golfers experience too frequently. There is also a large pitching and chipping green with a sand bunker along with a challenging putting green to sharpen your scoring skills. (\$195.00 & \$295.00; Single and Couple values, respectively)

#### **PREFERRED TEE TIMES**

Annual pass holders may schedule their golf reservations up to 21 days prior to the day that they would like to play. The general public may make reservations up to 14 days prior to the desired tee time. Please call ahead to reserve tee times as we may not be able to accommodate walk-ons on certain days.

The applicant hereby contracts those services and privileges indicated herein and agrees, if accepted, to pay all appropriate fees and to abide by and comply with all rules, regulations and policies in effect at time of acceptance or as amended from time to time. Applicant hereby acknowledges receipt and understanding of such rules, regulations and policies and agrees that such annual pass and the services chosen shall run from early April (or date of acceptance) until November 4, 2012. Applicant further understands and agrees for that any fees paid in connection with this application will not be refunded, transferred or prorated for any reason. However if this application is rejected or withdrawn prior to acceptance by The House on the Rock Resort and Golf Course, all funds previously submitted will be promptly refunded. ### The House on the Rock Resort - 2012 Golf Course Information & Policies

#### Reservations

- \*Tee times are available 21 days in advance for annual pass cardholders and 14 days in advance for the general public.
- \*At peak times, daily fee tee time reservations may need to be guaranteed by a major credit card.
- \*Tee time reservations for Unlimited Golf are based on availability (variations subject to Golf Shop approval). Players must check in prior to playing unlimited golf rounds or additional holes.
- \*Notice of cancellation must be received no later than 24 hours in advance of tee time or cardholder will be charged. Annual Pass Holders will be charged \$20 per golf round after 3rd no show.
- \*Children under the age of 14 must be accompanied by an adult when using the golf course or practice facilities.
- \*VISA, MasterCard, Discover and American Express accepted. Checks are not accepted.

#### Course Policies

- \*The Golf Course and Practice Facility are open from ~ 7:00 AM until sunset depending upon season.
- \*Tee time check-in should be at least 15 minutes prior to scheduled tee time. All players must check in with golf shop prior to beginning round.
- \*We reserve the right to pair singles and twosomes.**
- \*Play is governed by USGA Rules of Golf except where modified by local rules.
- \*A specific rotation of play among the three nine-hole courses will be observed at all time, unless prior notice has been given by Golf Shop.
- \*Appropriate golf attire shall be worn on the golf course and practice area. Please no beachwear, gym shorts, cut-off shorts, jeans or t-shirts.
- \*Replace divots, rake bunkers, repair ball marks on green.
- \*All players are requested to keep up with the group in front. If there is an open hole ahead, let faster groups go through.
- \*Pace of play will be monitored at all times. A maximum of 15 minutes per hole will be allowed; equaling 4 hours and 30 minutes for an 18-hole round. On-course rangers will have full authority to keep play moving at proper pace for all golfers' enjoyment.
- \*Limit your search for lost golf balls in the tall grass and wooded areas.
- \*There will be no more than four golfers per group without permission from the golf shop.
- \*Each player must have their own set of clubs. Rentals are available.
- \*Carry-on coolers are prohibited in accordance with state liquor licensing laws (WI Statute 125.32(6)). Refreshments can be purchased.
- \*Rain checks will be issued at the discretion of the Golf Shop due to severe weather conditions only. Light rain, mist or wind will not dictate the issuing of rain checks. In the event of severe thunderstorms or heavy rain, cancellation of tee times will be accepted until time of play.
- \*In the event of frost, the opening of the golf course will be delayed until approval by the Golf Course Maintenance Department. In this event, all tee times will be delayed accordingly.
- \*In the event of lightning, the golf course will be evacuated immediately. There will be **absolutely no exceptions**. The golf course will not re-open until the threat of lightning has left the area and the Golf Shop has notified players that the course is open. This is at the discretion of the Golf Shop.
- \*Thank you for playing ready golf and being considerate of our other guests.

#### Golf Cars

- \*All drivers must be at least 16 years of age with a valid Driver's License to rent or drive a golf car.
- \*All drivers must sign a golf car agreement prior to being issued the key and assigned a golf car.
- \*Players are responsible for any damage to the golf cars that they have been assigned.
- \*No more than two passengers at a time may ride in a golf car.
- \*Absolutely no reckless or careless use of golf cars will be tolerated.
- \*All golfers will be asked to obey the 90-degree Rule when operating a golf car. This rule states a driver should use either the golf car path or the rough at all times when traveling to their ball. Once they have come even with their golf ball, they should travel 90 degrees into the fairway and return to the golf car path or rough upon completion of their shot. Please respect this policy at all times.
- \*Golf cars should not be operated any closer than 30 feet from all tees and greens.
- \*On the days designated "GOLF CAR PATHS ONLY", golf cars will not be allowed to leave the golf car paths.
- \*All golf cars should be returned by dusk or shortly thereafter. Golfers on the golf course when dark will be removed.
- \*Guests will be allowed to use a golf car to see the grounds if not golfing, with certain restrictions and a small fee may be required.
- \*Failure to return golf car key will result in a \$25 replacement fee.

**All other policies may be enforced and/or interpreted at the discretion of The House on the Rock Resort. Failure to follow course policies may result in removal from property and/or revocation of annual pass without refund.**

\*Non-Prime Time Passholder: (After 1 pm): \$1,550 (w/ 5.5% sales tax = \$1,635.25)

\*WSGA handicap is \$25.00 for Twilight & Non-Prime Time Passholders (Normally \$30.00)
